Minutes

President Kristosik called the meeting to order at 5:07 PM

In attendance: Vince Kristosik, Joel Ritchie, Jim Cavin, Susan Young, Gaylon Kent, Sheila Seifer and Gail Anderson.

Approved minutes as amended from February Meeting

- 1) Scholarships – Send email advising members of the 2011 scholarships. This year will be open to graduating members, or children of members, in good standing with SNOA. \$4000 is set aside. Committee will make decision on size of scholarships and who receives. April 15th submittal deadline. Committee will make decision by April 30th.
- 2) Wrestling Board – Mike Guerino met with BofC. Positive comments on consistency of officiating this year. Discussed issues of fining/penalizing officials; criticism of fellow officials is unethical and cause for loss of membership; state tournament did not run as smoothly as last year when it was held in the South. Unpaid tournament fees will be forwarded to NIAA for their assistance in collecting. Same split of year end funds as last year.
- 3) Basketball S/T – Frank Roqueni met with the BofC. Discussed year end dollar split. Season went well.
- 4) Insurance Issue – Member requesting assistance with insurance billing was advised to ensure the doctor and insurance billings were coded correctly. SNOA is not able to assist with billing issues.
- 5) Volleyball Scholarship - \$200 scholarship for volleyball camp will go to Adam Candee in honor of Larry Conover.
- 6) Youth Football Payments – NYFL owes \$5567 and plans no spring league. NYS is paid in full for all past due. They will pay weekly for spring games. If payments are not received no officials will be on the field.
- 7) Basketball Survey - Basketball Board is sending out a year-end survey to get feedback from membership.
- 8) Basketball Board – Greg Hair represented the board for year-end discussions. Some issues with assignor and the year end payment were addressed. Crew system was a huge leap in the right direction with some small issues still to be resolved. Pleased with Instructional Chair. Year-end funds breakout will be sent to Treasurer within the week.

- 9) Soccer Board – Jack Young and Kevin Buckley met for year-end discussions. They feel a different venue would provide a better atmosphere for State. Soccer season went well; the board is taking a look at next years rating system; talk of combining boys and girls seasons in the next two years. Year-end funds split will be basically the same as last year.
- 10) Ethics Committee Hearing – Ethics committee advised that Track & Field not deny membership to an individual they wanted to reject. They suggested that membership be accepted with the understanding that registration does not guarantee any assignments. The BofC will get a legal opinion on accepting applications and their recourse. Need to archive the Ethics Committee minutes.
- 11) Breast Cancer Awareness – SNOA will receive 1200 pink whistles. Anonymous donor will match donations made to Bernie's Fund. Members can send an email to Treasurer requesting a donation be deducted from their check.
- 12) ASB Minutes – reviewed minutes from ASB.
- 13) New ASB Members – Tim Resch replaces Charlie Heislen on the Baseball Board. Marshall Cohen replaces Mike Seifer on the Softball Board.
